14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ **Effective as of the close of business on October 14, 2016, the Guidestone Funds International Equity Fund affected a reverse stock split under Internal Revenue Code Sec. 368(a).**

Each Institutional Class share of Guidestone Funds International Equity Fund (CUSIP: 40171W447, Ticker: GIEYX) declared a 1 for 1.351617 reverse stock split.

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶ **Upon effectiveness, the number of shares held by each shareholder were reduced by dividing the number of shares held immediately before the reverse stock split by the 1 for 1.351617 reverse stock split ratio.**

The basis of each post-split share of Guidestone Funds Equity Index Fund Institutional Class is equal to the basis of each pre-split share of Guidestone Funds Equity Index Fund Institution Class times 1.351617.

16 Describe the calculation of the change in basis and the data that supports the calculation, such as the market values of securities and the valuation dates ▶ **The aggregate basis of the shares before the reverse stock split is the same as the aggregate basis after the reverse stock split.**

The net asset value for each share of Guidestone Funds International Equity Fund Institutional Class (CUSIP: 40171W447, Ticker: GIEYX) before the reverse stock split was \$9.9691.

The net asset value for each share of Guidestone Funds International Equity Fund Institutional Class (CUSIP: 40171W447, Ticker: GIEYX) after the reverse stock split was \$13.4744.
