14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ **On November 20, 2015, the Guidestone Funds Conservative Allocation Fund I merged into the Guidestone Funds Conservative Allocation Fund in a tax-free exchange under Internal Revenue Code Sec. 368(a).**

Each share of Guidestone Funds Conservative Allocation Fund I (CUSIP: 40171W843, Ticker: GFIYX) was exchanged for .807689 shares of shares of Guidestone Funds Conservative Allocation Fund - Institutional Class (CUSIP: 40171Y500, Ticker: GCAYX).

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶ **Each shareholder's aggregate basis in the shares they received in the exchange will equal their aggregate basis in the shares they surrendered.**

The basis of each share of Guidestone Funds Conservative Allocation Fund - Institutional Class (CUSIP: 40171Y500, Ticker: GCAYX) received is equal to 123.8100% of the basis of each share of Guidestone Funds Conservative Allocation Fund I (CUSIP: 40171W843, Ticker: GFIYX) surrendered.

16 Describe the calculation of the change in basis and the data that supports the calculation, such as the market values of securities and the valuation dates ▶ **The aggregate basis of the shares received is the same as the aggregate basis of the shares surrendered.**

The net asset value for each share of Guidestone Funds Conservative Allocation Fund I (CUSIP: 40171W843, Ticker: GFIYX) surrendered was \$9.2965.

The net asset value for each share of Guidestone Funds Conservative Allocation Fund - Institutional Class (CUSIP:40171Y500,Ticker:GCAYX) received was \$11.5100.
